Teachers and administrators at Lakeside came together during pre-planning week to review and discuss the prior year's assessment data. Information was organized to show individual teachers, grade level, and school-wide results. Teachers analyzed academic achievement results in all core subjects and subgroups including SWD and ELL students.

At Lakeside Elementary, recruitment and retention of high-quality teachers is a priority. In order to attract highly qualified teachers, we search the online system and conduct family-style interviews with our interviewing panel. Lakeside has a positive reputation in the community and district, so we pride ourselves in the fact that many teachers would like to work at our school. In addition, teachers new to the profession or new to the school participate in a Lakeside mentoring program. Teachers meet monthly with their peers and T.I.E.R. Liaison. Teachers also meet weekly with their mentor.
