  - a. Literacy-Pacheco- monitoring student assessments (Benchmark etc). Lots of professional development- especially in grades 3-5. Small group focused. Mrs. Pacheco will be out soon on maternity leave and will have an experienced substitute to provide extra help.

- b. BTU-Duran- won the vote for early release days this year. Family and child insurance costs have doubled. Groups are meeting to negotiate. The state is offering zero dollars for raises. A+ funds are still being discussed.
