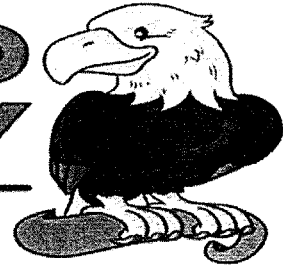

1. **Call to Order:** A meeting of the Dillard Elementary School SAC was held on Tuesday, January 27, 2026 at 5:00pm in the media center. The meeting was called to order at 5:00 p.m.
2. **Introductions and Attendance:** 26 people were present at the SAC meeting. 9 of the attendees were on the SAC committee.
3. **Approval or Correction of December 2025 meeting minutes:** A motion was made by Ms. Kelly to approve the November meeting minutes. Ms. Wilson second the motion. The minutes were approved unanimously.
4. **Reports:**
Principal Report: Mrs. Robinson welcomed all stakeholders. She proudly announced that we meet all our PM2 goals in all subject areas. She mentioned that we are still focusing on ELA. Students that are our lowest quartile in 3rd, 4th, and 5th grade are getting additional ELA support. She asked parents to please continue to make sure kids are in school daily and on time. Although we are above 90% in our attendance rate, we want to cut down on tardies.
There are no SESIR reports this year at our school.
Accountability funds - \$13, 272.00
5. **A+ Recognition Funds** – The staff voted for 100% to the 2024-2025 faculty and staff divided equally.
6. **SIP PLAN** – Mrs. Quana Smith presented the 25-26 School Improvement Plan and Title I Addendum to include all stakeholders' suggestions for the 26-27 School Improvement

Plan. Mrs. Smith made a motion to accept the 26-27 School Improvement Plan. The committee voted to approve the plan unanimously.

7. Title 1 Updates –

8. SAF Information – Open positions in schools are being field by district personnel.

- 60 staff members deployed to schools to fill open instructional positions based on background and certification.
- 30 staff members remain available for deployment.
- Schools are required to submit updated staffing needs weekly (every Monday). An estimated 1,200 students who previously did not have a teacher now have coverage

Some concerns for the district are –

- Will these staff members be placed permanently?
- Who is filling the positions that the district personnel had?
- Whether ESE, support facilitators, or other critical roles are being reassigned. Whether formal written guidance exists specifying which roles cannot be touched.
- Some open positions are security positions and stakeholders are wondering will the hiring freeze affect safety in schools.

Playgrounds








- 65% of district playgrounds have been inspected.


