



Call to Order:

A meeting of the Walker Elementary School Advisory Council was held in the media center on January 22, 2026; Co-Chairs Tranecia Walker and Ebony Jones called the meeting to order at: 3:33 PM. Tamara Lang will record minutes for this meeting.

Minutes: Review of SAC Meeting notes from December 10, 2026. Meeting notes were reviewed and approved.

Reports:

1. **SAC Co-Chair:** Ms. Jones welcomed all to the meeting.
 - Ms. Walker reviewed the agenda with the staff and parents.
 - Ms. Jones began to discuss the first items on the agenda: the review of the compact letters and family engagement plan.

2. **Upcoming School Year Parent Compact:**
 - Ms. Jones made a proposal to review the Parent Compact form and discuss if we want to make changes for the upcoming school year. The following changes to the Parent Compact Form were proposed:
 1. Under Section 2: Remove "within the classroom setting"
 2. Under Section 3: Replace "Report Cards will be sent home every quarter" with Report Cards will be available on Focus and print upon request.
 3. Under Section 4: Replace "7:30am with 7:45am" in "Administration and Staff support will be available at 7:45 and throughout the school day as needed.
 4. Under Section 5: Remove "mentoring"
 5. Under Parent Responsibilities: Replace "television my children watch" with "screen time"
 6. The vote to make the changes was approved unanimously.

3. **Upcoming School Year Parent and Family Engagement:**
 - Ms. Jones made a proposal to review the Parent and Family Engagement Plan and discuss if we want to make changes for the upcoming school year.
 1. Under the coordination and integration section we propose to change Curriculum Night to Parent Night.

2. Under the Building Capacity section: we propose to change Academic/Curriculum Night to Parent Night.
3. Under the Staff training section: we propose to add iReady Training.
4. Under the Accessibility section: We proposed to remove the School Parent Involvement Plan and replace it with the FACE Plan.
5. The vote to make the changes was approved unanimously.

5. **Accountability Funds:**

- Mr. Frye proposes using \$19,700 of accountability funds to be used towards:
\$16,800 for ELO Enrichment Camp
\$5,000 for Instructional Materials
\$1,360 for Student Incentives
- The remaining balance will come from other school funds.
- The vote to use the accountability funds was carried unanimously.

6. **SESIR reports.**

- Everything has remained the same.

7. **SAF Report:**

- There was nothing to report from SAF because the chairperson was not in attendance.

8. **Questions and Concerns:**

- Parents and staff want to know if the school provides a supper program. Staff will get in touch with Ms. Ericka Floyd.
