## Call to Order:

- A meeting of the Oakridge Elementary School Advisory Forum was held in person on May, 2026. Mrs. Davis called the meeting to order at 5:12. Mrs. Davis will take the minutes for today's meeting. April SAC minutes were reviewed and approved. Ms. Donald motioned to approve the minutes. Ms. Salazar seconded the motion. Mrs. Davis reviewed the goals of Oakridge and SAC- Increase student achievement, diver deeper into curriculum, improve academic strategies for ALL students, and increase community engagement.

## New Business:

### Principal's Report:

Ms. Pinder shared information regarding Policy 1403 and the projected budget for the 2026–2027 school year. Student enrollment is projected to be approximately 415 students, with a total allocated budget of \$3,408,222 for the upcoming school year. As part of staffing adjustments, the school lost one teacher position. In addition, the ASD cluster units were reduced from five clusters to four clusters. For ESE support facilitation, the school will maintain 1.5 positions, consisting of one full-time and one part-time support facilitator. Ms. Pinder also shared updates regarding the Pre-K program. The school will continue to have one Specialized Pre-K and one DPK program, and additionally earned one new intensive Pre-K unit, bringing the total to two intensive Pre-K programs for the upcoming school year. Staffing levels in Kindergarten, 2nd grade, 3rd grade, 4th grade, and 5th grade will remain the same for the 2026–2027 school year.


