Miramar Elementary School Advisory Council/School Advisor Forum Minutes March 18, 2024

Attendance:

Ms. Schlissel-Principal, Mrs. Dumervil- Assistant Principal, Mrs. Vargas- SAC Chair, Ms. Demps- staff, Ms. Williams-1st grade teacher, Mr. Pintavalle- BTU Steward, Olydia Clarke- Community Representation. We had a quorum.

Call to Order:

A meeting of the Miramar Elementary School Advisory Council was held in the school's conference room on March 18, 2024. Mrs. Vargas motioned to open the meeting at 2:23 PM and recorded minutes for this meeting.

Agenda Items:

- Introductions of staff members (Ms. Schlissel, Mrs. Dumervil, Mrs. Vargas, Ms. Demps, Ms. Williams, Ms. Olydia Clarke, Mr. Pintavalle).
- Principal's Message: Ms. Schlissel greeted everyone and wished everyone a safe spring break for next week. She shared testing will be taking place after spring break. We have writing testing in the month of April and FAST testing for ELA and Math as well as Science State Assessment in May. Summer school information was emailed to staff members. Application has not been opened yet. Summer school will be held for 4 weeks beginning June 24 and ends July 18 with 1 off day for July 4. Hours will be 7:30 3:00, Monday through Thursday. She shared Title I budget has been reduced by an estimated \$28,000. Title I funds will be used to purchase agendas (costing \$2,000) and salaries to keep our ELA and Math coaches.

• Title I:

- O Mrs. Vargas reviewed upcoming school year's School Level Parent and Family Engagement Plan. Plan was emailed to all attendees. Mrs. Dumervil shared we will keep out Literacy nights for next school year and our top areas of focus are ELA, Math, and Science. Parents, Teachers, and Community Members were invited to give input. No input provided by teacher, parent, and community.
- Mrs. Vargas reviewed the current school-parent compact and discussed the development of the upcoming school year's school-

parent compact. School-parent compact was emailed to all attendees. Mrs. Dumervil shared how the School-Parent compact was shared with parents who attended Kindergarten Splash on Friday, March 15. Parents, Teachers, and Community Members were invited to give input. No input provided by teacher, parent, and community.

- Mrs. Dumervil discussed the components of the School Improvement Plan: Attendance Plan. She shared our key players in our attendance plan are teachers. Teachers contact parents after three consecutive absences. After numerous contacts, teacher then creates a referral for our school worker to do a house visit. Attendance team is made of Mrs. Guasp and Mrs. Dumervil. Parents are to call the attendance hotline, Mrs. Guasp records all reports made to the hotline and Mrs. Dumervil makes any additional calls if necessary. If attendance issues do not get resolved by the school, it then gets reported to the state. Parents, Teachers, and Community Members were invited to give input. No input provided by teacher, parent, and community.
- Mrs. Vargas reported there was no new SESIR incidents this month. Parents, Teachers, and Community Members were invited to give input. No input provided by teacher, parent, and community.
- SAC Funds: \$29, 438.37. Quorum was present to vote for two resources: Wordly Wise and Quick Reads. Mrs. Vargas motioned to vote for Wordly Wise to help with vocabulary and Quick Reads to help with close reads costing a total of \$8,419.55. Leaving SAC funds at \$21,018.82. Mrs. Demps seconded the motion. 6 voted unanimously.
