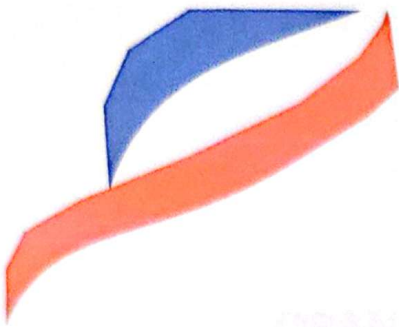

1. **Call to order:** Mrs. Braynen called to order at 3:15 p.m.
2. **Attendance:** Mrs. Owens, Mrs. Braynen, Mrs. Winfree, Mrs. Delucia, Ms. Baron, Ms. Frazier, Ms. Shabreya Johnson, Ms. Alexis Talley, Mrs. Catherine Winfree, Mrs. Colon
3. Approval or correction of September 24, 2025, minutes: motion to approve by Mrs. Delucia and seconded by Mrs. Colon

Reports:

- a. **Principal's report:** Mrs. Owens stated that we will not have ELO camps and academic camps this year as of now. Our leadership team is working diligently to put together a plan for pull out groups to work with students who just need that extra push. Students will be pulled for 45 minutes Monday through Thursday.
- b. **SESIR report:** Mrs. Owens stated that there are none to report.
- c. **Accountability funds:** Mrs. Owens explained that there was a \$8,368.00 balance. Mrs. Braynen explained that it is up to the SAC committee to decide where the funds will be used. She asked if anyone had suggestions on the use of the funds. Mrs. Macon asked if the money could be used for student technology. Mrs. Braynen explained that we were fortunate enough to already have laptops for every student and other technology. Ms. Frazier stated we normally use the monies for student incentives. Mrs. Owens asked for \$5,000 for student incentives such as pizza parties and any other incentives. Mrs. Braynen asked for a motion to be placed. Motion to accept Mrs. Owens' request for \$5,000 to be used for student incentives by Ms. Frazier and seconded by Ms. Baron.
- d. **School Improvement Plan:**
Mrs. Braynen provided copies of the 2025-2026 School Improvement Plan to stakeholders. She explained that it is up to the SAC to periodically review the SIP and make suggestions and/or changes as necessary. Once the plan was reviewed, Mrs. Braynen asked if anyone had any suggestions or changes such as additions or deletions. There were no suggestions. Mrs. Braynen stated that we would revisit this at a future meeting.
The leadership team is working on the best way to formulate groups for Pull Outs in Reading, Math, and Science.
The leadership team is disaggregating data to see which students will participate.
- e. **Academics:**
 - a. **Mrs. Braynen shared scores and discussed that although we are not where we want to be, students are definitely trending in the right direction. Mrs. Owens shared her plan to ensure scores continue moving upward. Administration and Instructional leadership will continue walk-throughs and make sure teachers are teaching with fidelity and keeping up with the District Scope and Sequence for all subject areas.**
 - b. **Mrs. Owens stated that we had to put our Acaletics order on hold for now, but would possibly be able to get them soon. Mrs. Braynen stated that this is a purchase that would be well worth it, as it is a great spiral review for students and teachers actually use it daily.**
