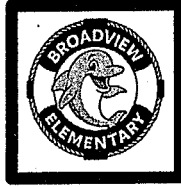

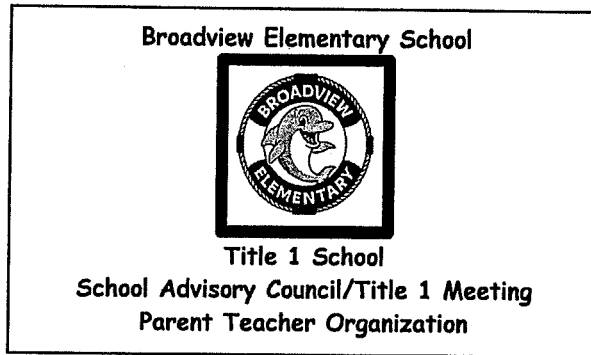

School Advisory Council Meeting Minutes – Wednesday, December 17, 2025

Call to Order:

A meeting of the Broadview School Advisory Council was held **Wednesday, December 17, 2025**, in the cafeteria. **Chair Ms. Diamond** called the meeting to order at **2:30 p.m.** Introductions of those presenting were done. Quorum was met; request for use of accountability funds will be voted on.

Minutes:

- Minutes from the SAC, **11-5-2025** meeting presented to all guests.
- Motion to approve **11-5-2025** SAC minutes by C. Diamond.
- Seconded: J. Smith seconded the motion.

New Business:

- Repairs from the flood in September are almost complete. Still waiting for furniture to be delivered to the main office.
- Varsity Tutoring for 4th and 5th grade students with a focus in math will begin January 6th, 2026. Tutoring sessions are 2x/week, 40 minutes each session. Sessions are as follows:

Wed. – Thurs. 2:15 – 3:00

Motion now opened for discussion by C. Diamond, SAC Chair. It was noted that the purpose of repairing the school's marquee is to enable the PTA to use it for school fundraising activities as well as a way to communicate to families upcoming school events, reminders and achievements.

After an explanation of the planned repairs, the motion to allocate the School's Accountability funds for repairing the school marquee was approved with 9 votes in favor and 3 opposed.


