General Meeting in the New River Middle School Exploratorium on Wednesday, April 2nd, 2025 -4:30 PM

I. Call to Order:

A meeting of the New River Middle School Advisory Council was held in the media center. SAC Chair Ronald Jules called the meeting to order at 4:40PM. 19 members were in attendance. Ms. Coombs recorded minutes for this meeting.

II. Review of Minutes: Mr. Jules reviews last month's meeting minutes with the audience. Mrs. Frazier-Wright made a motion to accept the March meeting minutes. Mrs. Esser seconded the motion.
