SAF Meeting Minutes – May 7 2025

Central Area Advisory Meeting held on April 17<sup>th</sup> update:

The guest speakers for the April CAA meeting were from the office of support and compliance IEP and 504 Plans. They started with the basics from federal IDEA-the law that governs individuals with disabilities act and how it governs state and public agencies. This law IDEA protects infants through young adults up till the age of 21. SEA is the policies and procedures for the Florida Department of Education and how it adheres to IDEA. The LEA is local education BCPS which covers toddlers with early interventions through 21 years old. BEESS is the bureau of exception student education and student services. They oversee that policies and procedures are being met. When our students have an IEP or 504 plan they should be receiving annual meetings, evaluations, timelines, and those involved with the student should receive training.

There is also an office for those older students preparing for post- secondary life. 504 and IEP's are for students with disabilities, temporary disabilities, health concerns and learning or behavioral disabilities. Anyone from the teacher, parent, or counselor can express concern and start the process for an evaluation. There will be a school-based team to review records, concerns, medical diagnoses and decide on next steps. The Calendar committee has already begun to discuss the calendars for 2026-2027 and 2027-2028 school years.

Broward Estates (the elementary school closing and becoming a community support center) will be having a fun day on May 17<sup>th</sup>.
