Meeting Minutes

I. Welcome/Introduction

Ms. Pompey welcomed attendees to the first SAC meeting. She called the meeting to order at 2:37 pm. Motioned to begin meeting Ms. Miller, seconded by Ms. Dorsett.

II. Redefining

There was an update for SAC members and attendees about redefining our schools. The option of Sunshine Elementary and Fairway Elementary merging for the 26-27 school year was discussed. It was explained to attendees that the final decision has not been made of which school building will have the merger. More information regarding the transition is forthcoming.

III. Curriculum Updates

Tier 2 and 3 students that receive interventions will take the iReady Growth Monitoring Assessment.

IV. SAC Accountability Funds

Ms. Dorsett discussed the purpose of accountability funds and how the funds assist our school. A proposal was sent to SAC requesting \$9,000 for student incentives, safety gate screenings, and debate club gear. SAC members voted on the proposal, and it was approved.

V. School Environment Safety Incident Reporting (SESIR)

Ms. Pompey explained to council members the purpose of SESIR and how schools track incidents and analyze patterns of violent, criminal, or disruptive activity. The intent is for there to be complete and objective data from which to design interventions to improve the learning environment.
