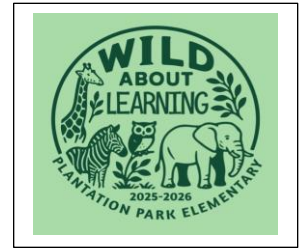

Executive Board Slate












