 - a. Mr. Kenney called the meeting to order at 6:05 pm

 - a. Principal Update
 - i. Next week, we are off for Thanksgiving
 - ii. Keep an eye out for "Celebrating Holiday Countdown"
 - iii. The iReady store will open after winter break.
 - iv. The Burlington \$5,000 went directly to the teachers. Teachers have access to many online stores to purchase items for their classroom.
 - v. We have identified a new music teacher! The individual is going through the hiring process at this time.
 - vi. On December 17, we will have a Winter Academic Family Night. A topic to be discussed: "Strategies for Helping with the Winter Break Slide."
 - b. SIP Monitoring
 - i. PM2 is almost here! KG-2nd will take the STAR assessment, and 3rd-6th will take the FAST assessment. Both assessments will be administered in December, before winter break.
 - ii. PM3 data is the primary promotion criterion for students. If students do not pass the PM3 criteria, there are other assessments for teachers to give for promotion.
