SAC Minutes - January 7, 2026

---

**Call to Order:** Meeting was called to order by Ms. Philippe at 5:10pm, the pledge of allegiance was recited and attendance was taken at the meeting

## **New Business:**

Ms. Philippe welcomed and thanked all the attendees for attending the SAC meeting for the month of January.

- Ms. Philippe provided an overview of the meeting agenda, including school updates, testing schedule, recognition fund ballot proposal, school construction updates, accountability funds information, and PTA updates.

## **School Updates/Testing Schedule updates**

- Testing Schedule and Student Performance Updates
  - Ms. Phillippe discussed the testing calendar and mentioned that makeup testing (F.A.S.T and S.T.A.R. Renaissance. Makeup test dates have been scheduled for January 6<sup>th</sup> through January 23<sup>rd</sup> 2026.
  - I-Ready (ELA/Math) Diagnostic assessment will be administered to students in grades Kindergarten through 5<sup>th</sup> grade. Grade levels will have students take the assessment over the course of two days. Makeup dates will be January 14<sup>th</sup>- 30<sup>th</sup>, 2026
  - Science M.O.Y (middle of the year) assessment will be administered to 5<sup>th</sup> grade students. Assessment date is January 21- January 22, 2026. Science M.O.Y makeup dates will be January 23<sup>rd</sup> and January 26<sup>th</sup>, 2026
  - Ms. Philippe also provided parents with an important concern/update as it pertains to burrowing owls nested on our campus. Ms. Philippe reminded SAC attendees on the importance of reminding young scholars and adults to remain away from the designated nesting burrow/nest of the burrowing owls to prevent any incidents.

## **School Recognition Funds Ballot Proposal**

### *Results from online poll*

- Ms. Philippe provided a detailed breakdown printout of the results from the online voting poll on how staff members would like to utilize the A+
- Ms. Philippe, along with the SAC committee and stakeholders and attendees, all reviewed the poll results and narrowed the selections down to two options proposal selections to be added to the upcoming voting.
- The two proposals selected for ballot voting are:

1. Dividing the money equally between all three instructional learning subject area (ELA, Math, & Science) and allowing instructional coaches to collaborate with teachers on which curriculum and materials are needed for grade levels.
2. Purchasing an alphabet magnetic board with letters, structured and culturally diverse classroom libraries (learning level books), classroom headphones (strong & durable), classroom materials (anchor charts, markers, crayons, etc.)
  - Ms. Philippe will prepare the voting advertisement, along with voting ballots to ensure that voting is done in accordance with SAC guidelines. Advertisement will be done for three days prior to the actual voting day. A representative from all stakeholders will be present to ensure representation while voting.

### **School Construction**

Ms. Allen welcomed all stakeholders and attendees for coming out to our SAC meeting for the month of January

- Ms. Allen wanted to provide a small recap of what events and activities that were done around the school during the months of November (Thanksgiving basket drive coordinated by the guidance counselor and partnerships), and in December (students participating in jingle bell choral and shopping with Santa)
- Ms. Allen provided an update as it pertains to the demolition of building 1 on campus. Demolition began on December 20, 2025 when the campus was closed during the holiday/winter break. January 30, 2026 building one is expected to be demolished and flatten down.
- New building anticipated completion date is scheduled for the year 2027.

### **Accountability Funds**

- Per Ms. Allen, as of January 7, 2025 C. Robert Markham Elementary has funds for supplies and materials in the amount(s) of :
  - \$8,475.00 for supply purchases (office supplies, classroom supplies, student supplies)
  - \$2,740.00 for Instructional materials (workbooks, curriculum materials, etc.)
- Purchases are made utilizing accountability funding for student achievement in alignment with C. Robert Markham Elementary School improvement plan (SIP).

### **SESSIR**

- Mr. Frazier welcomed the attendees to the January SAC meeting. He also informed attendees that there were no SESSIR incidents or reports on them for the month of Jan

### **PTA**

- Ms. Phillips welcomed and thanked everyone for attending the SAC meeting. She had some new business and reoccurring business that she wanted to share with everyone.
- The holiday shop which took place in December 2025 was able to make sales totaling \$1,006.00. The school is expected to receive a percentage of the sales amount.

- The Scholastic Book fair which also took place in December was able to make sales in the amount of \$3,753.55. For C. Robert Markham Elementary to receive a percentage in sales from scholastics a sales quota of \$3,800.00 would need to be met and unfortunately that sales quota was not met. Scholastics will provide the school with \$1,826.56 credit to purchase books via the scholastic catalog
- Ms. Philipps stated that there is funding in the PTA accounts to help with sponsoring schoolwide and afterschool events.
  - Students- \$1500 (nothing has been utilized or touched for students )
  - Teachers- \$995 (\$490 was utilized in November for Staff and Faculty luncheon)
  - Parents- \$600 (nothing has been utilized for parents)
  - PTA members- \$863.00 PTA conference for 2026
- Ms. Philipps would like to organize more PTA meetings to help with engagement and participation.
  - We currently have 19 PTA members and would love more.
  - Ms. Phillipps is trying to organize a parent appreciation day/night event.
  - Day event would consist of providing parents in the drop off lane with small token of appreciation (small muffin or donut with mini water)
  - Night event would consist of a family game night with small refreshments served. This allows collaboration and engagement to build strong bonds and connections
