A meeting of the Deerfield Beach High School Advisory Forum was held in the School's Media Center on November 18, 2025.

Approval of Minutes:

Approved in SAC meeting as the last meeting was a joint meeting between SAC and SAF.

District Advisory Updates

a. Redefining our Schools

- a. There were no members present who attended any redefining our schools meetings. Mr. Williams overviewed the points of conversation from the three meetings, noting that there were no potential school closures in the North Area. The focus is a shift in programming within a few schools in Coral Springs. The conversations were different in the Central and South areas, as there are a few schools up for closure or some form of consolidation.

Old Business

- a. There was a conversation about the district's plan to address vaping across the county outside of the upcoming bathroom vaping monitors. Members were inquiring on the district's programs that are currently in place to curve the unwanted behavior as the vaping epidemic seems to continue to increase.
- b. A parent questioned the discipline plan for vaping, and the discipline matrix was reviewed. A community member asked for more positive reinforcements to curve the behavior.




