- At least one school has lost support staff due to Title I funding being reduced due to the lack of applications being completed.
- Angel funds and district funds are being looked at. Money is being accepted in cash.
- They also want to look into the Hazel health program, which is no longer being available. We need to provide more resources to parents.
- Attendance, achievement growth. A rated district for the second time in a row. There are no schools that are D or F schools. The goals have only A-B schools. Currently, they're 84%.
