**Call to Order:**

A meeting of the Mirror Lake Elementary School Advisory Council was held in the Media Center on 02/06/2026. Chair Andrea Cutrone called the meeting to order at 7:15am. Kiara Johnson will record minutes for this meeting.

**Reports:**

1. Principal Report
  - Mirror Lake isn't affected by redefining schools
  - February 21<sup>st</sup>- Family Fun Day from 11a.m.- 3p.m.
2. SESIR: School Environmental Safety Incident Report
  - Nothing to report currently
  - Currently up to date with safety drills
    - Only 4 Lockdown drills are now required
3. Accountability Funds- \$2,866.67
  - Funds could possibly be used to purchase "Performance Coach" for 3<sup>rd</sup>-5<sup>th</sup> grade students

#### 4. Title I

- **2026-2027 Annual Title I School Parent and Family Engagement Survey Results**
  - Percentage of parents who “agreed” or “strongly agreed” in all the questions showed upwards of 70% or above
  - Lowest areas (40%) indicated that parents believed that they aren’t receiving adequate materials for students to work on at home
  - 40% of parents “strongly disagree” with translators being readily available for help at parent meetings and other school activities
  - Overall responses to questions reflected positively and the weakest areas will continue to be worked on
- **2026-2027 School Parent Compact Review**

The School Parent Compact was presented to parents and community members. It was explained that the School Parent Compact is similar to a contract between parents, the students and teachers in order to understand the rules and procedures to be followed throughout the year. Parents were provided with a copy of the 2026-2027 School Parent Compact to review and discuss. Parents were asked to give feedback regarding the compact. Parent feedback was that number two specifies that conferences should be talked about during the open house, however, this does not occur since parents don’t get the opportunity to discuss about a conference with teachers during Open House. Instead, teachers should be able to talk about the expectations of conferences during the Open House. The committee decided to amend item number two of the School Parent Compact. No other feedback was given.
- **Review of the 2026-2027 Parent Level and Family Engagement Plan**
  - Review for the following school year to reflect current dates and data
  - The 2026-2027 Parent Level and Family Engagement Plan was presented to the Committee and reviewed. Parents were asked if they had any questions or input regarding the plan. Parents agree with having academic trainings that are fun, interactive and support student learning success. The 2025-2026 Title I Annual Survey results continue to show an improvement in the area of Parental Engagement and the school is committed towards increasing Parental Engagement since this has proved to also help with students’ academic success. No other feedback or input was given at the moment.

  - 3<sup>rd</sup> grade: 40%
