a. Accountability Funds

b. Testing & Class Size Reduction

- Inquiry: Whether unused accountability funds will be reinstated
 - Principal Curran explained funds were unavailable due to budget challenges
- PSAT Funding Request:
 - \$7,140 PSAT funding requested
 - The cost is \$7 per test for up to 595 juniors: \$12 per test for up to 140 seniors
 - The goal for providing this test to the junior class and senior students is to provide students with the opportunity of receiving their concordance score for graduation as well as provide them with National Merit eligibility
 - Motion: L. Mallozzi made a motion to approve up to \$7,140 for PSAT test for Juniors and Seniors. The school will contact the parents and students to get a list of students that want to test.
 - Seconded: A. Alston (Parent) seconded the motion.
 - Opposed: L. Garfinkel
 - Motion passed with majority vote
 - L. Garfinkel requested post-test student survey
- Class Size Reduction Request:
 - \$6,000 requested to fund an extra Algebra 2 teaching period
 - Motion: S. McCarthy (Parent) made a motion to approve the \$6,000.
 - Second: J. Spigelman (Parent) seconded the motion.
 - Motion passed unanimously
