Meeting Minutes

I. Welcome & Roll Call to Establish Quorum

Dr. M. Glynn welcomed all SAC members to the SAC meeting. She called the meeting to order at 5:30 p.m.

Dr. M. Glynn conducted a roll call of SAC Committee members. 7 SAC Committee members were present out of 13, which made 54%. Quorum was established.

II. Presentation of the February SAC Meeting Minutes For Approval

Dr. M. Glynn presented and reviewed the minutes from the last SAC meeting held in February. Dr. M. Glynn asked for a motion to approve the minutes. Ms. S. Jennings made the motion, and Ms. R. Husbands seconded the motion. The motion passed.

III. New Business

Title 1

Dr. M. Glynn reviewed the 2025/2026 Parent and Family Engagement Plan (PFEP). She discussed the components of the PFEP and asked SAC members if there should be any changes or deletions to the 2026/2027 Parent and Family Engagement (PFEP). SAC members were given the opportunity to review the plan and provide input on the upcoming plan. There were no other suggestions on changes or deletions to the plan.

Dr. M. Glynn also reviewed the 2025/2026 School-Parent Compact. She discussed the components and asked SAC members if there should be any changes or deletions to this document for the 2026/2027 school year. Dr. M. Glynn reviewed the Attendance Goals for the District and Banyan's goals include the following:

Goal 1: Excused Absence Rate Improves by the end of the 25/26 school year.

Goal 2: Students with Attendance Above 90%-Our goal by the end of the 25-26 school year is to maintain or exceed the elementary average, which is 60.4%.

Goal 3: Total Chronic Absenteeism-Our goal is to decrease overall chronic absenteeism at our school by at least 1% by June 2026.

Goal 4: Severe Chronic Absenteeism-Our goal is to decrease severe chronic absenteeism within our school community by June 2026.

Dr. M. Glynn emphasized that the school's approach to addressing attendance concerns is rooted in support rather than punishment or blame. She highlighted the use of positive incentives to encourage improved attendance and noted that teachers play an active role in identifying students with attendance concerns by reaching out to families through conferences and communicating with administration. The school social worker also collaborates in providing additional support.

Additionally, Dr. Glynn shared that students with strong attendance are acknowledged and celebrated during quarterly awards assemblies. Students who arrive on time may also receive incentives such as access to a complimentary breakfast. Most importantly, consistent attendance ensures that students remain engaged in classroom instruction and do not miss valuable learning opportunities.

Dr. M. Glynn asked all in attendance if there was any additional input, feedback, questions, comments, or concerns. Parents and SAC members were given the opportunity to provide input, but none was given.

Principal Updates

Mrs. S. Jennings reviewed the Parent Involvement Allocation for 2025/2026. These funds are used for professional dues, supplies, like construction paper, flyers, newsletters, and other items needed as paper resources for Title 1, student agendas, and refreshments for the various family night events. Mrs. S. Jennings shared average pricing for various items. Mrs. S. Jennings asked SAC members if there should be any changes to the Parent Involvement Allocation for the 2026/2027 school year. There were no suggestions, and it will remain the same for the upcoming school year.

Mrs. S. Jennings reviewed the Accountability Funds. We currently have approximately \$167.03. She explained that the Accountability Funds are funds that roll over every single year until we use them.
