1. Marquee Repair

The process is moving forward with Signs Plus and will be 4.6 ft x 8 ft, with 16 sq ft of digital screen that can show animated videos in a high resolution, 60 frames per second and 36k pixels. It will have remote diagnostics and communication via cell data modem, so it can easily be programmed from anywhere at any time. The estimated time for completion is 6-8 weeks.

- d. A motion by Ms. Zaldumbide to approve \$1,980 for SAT Registrations for seniors that still need to meet graduation requirements. Ms. Fein seconded the motion. The vote passed unanimously (13 votes total).
