**1. Call to Order and Welcome**

**2. Principal's Report – Ms. Reynolds**

- Spring 2026 testing preparation is underway; the testing calendar has been shared via ClassDojo.
- The Media Center renovation is projected for completion by August 2026.
- The Assistant Principal has been reassigned to support district needs. Ms. Reynolds will continue to serve as Principal. In the absence of an assigned Assistant Principal, neighboring administrators will provide ongoing support to Atlantic West Elementary.

No additional input or concerns were raised. Continued engagement was encouraged.












#### **9. Adjournment**
