21st Century After School Program:

- Mrs. Reynolds shared an opportunity for the school to apply for the 21st Century Community Learning Centers Grant. If awarded, the grant would provide free after-school programming for students. The program would focus on supporting academic achievement, particularly for students performing below grade level.

- The SAC committee voted on the grant opportunity, with 11 out of 15 members in favor. The motion to pursue the grant was approved.

Additional ELO Camp funds:

- Mrs. Reynolds requested approval to allocate an additional \$2,000 from School Accountability Funds to support teacher compensation for ELO Camp. The SAC committee voted, with 12 out of 15 members approving the use of the additional funds.
