 - The meeting was called by Ms. Baptiste at 5:37 pm and seconded by Ms. Monestime. Ms. Baptiste welcomed the committee and guests to the second meeting.
- August SAC Minutes approval
 - Ms. Baptiste shared the August SAC minutes for committee members to review and approve. All members approve.
- 2025 - 2026 School Improvement Plan
 - Ms. Reynolds shared that state SIP plan is process of review and will be shared with the committee pending approval. Due to our Federal Index being below 41% for ESE students (37%), we have to create a local and state plan.
 - Mrs. Reynolds shared a couple of goal ideas for school improvement in areas of increasing students attendance level and setting grade level goals.
 - Ms. Reynolds asked the committee if they had input, questions or concerns regarding the SIP process. No input provided by teachers, parents or community.

Mrs. Reynolds explained that funds will be used for salaries, ELA camp, and needed school materials.
- Principal's Report
 - AWE has completed roofing repairs, and the media center is scheduled to begin construction September 15th, 2025, to put up walls. Boys' and girl's bathroom also to be updated to meet ADA requirements.
 - The goal is to increase to 50% in all areas by the Spring FAST PM3 assessment.
- Accountability Fund \$21,271.16
 - Ms. Baptiste explained what the Accountability Fund is, how it's used and how it is allocated for our school. Last year, funds were used to purchase a laminator and poster maker for teachers.
- School Environment Safety Incident Report (SESIR) - 0
 - Ms. Baptiste explained the varying types of SESIR events to the committee members.

- o Ms. Baptiste encouraged guests to continue to join our monthly SAC meetings and bring two friends each month because community input is vital for our school.









