A meeting of the Horizon Elementary School Advisory Council was called to order at 2:20 PM. Ms. Edmund welcomed everyone. Introduced herself as the new SAC Chairperson and Mrs. Lohsen Tucker as the SAC Secretary.

Review of May 29, 2025 meeting

Mrs. Tucker reviewed last year's final meeting. No questions were raised.

Training: Work of the School Advisory Council (SAC)

Ms. Edmund shared the function of Horizon's SAC to the stakeholders present.

Principal's Report/Budget Update

Mr. Smith celebrated/reviewed our 2024-2025 data and our "A" status. He also explained our projections for this school year and how we plan to maintain our "A". As aligned to district goals, our plan is to focus on a 3% proficiency growth. Our goal for 3rd grade is lower than the proficiency from last year, as we know that foundational skills are our focus for the 3rd grade students this school year.

Projected School Accountability Funds for next year=\$2,375. Mrs. Tucker explained the purpose of these funds.
