 - A. The district is still in the process of updating their website to make it more user friendly, clean, and marketable.

 - C. Intercoms Report - All classrooms (including portables) have intercoms.
 - D. Free and Reduced Lunch is tied to Title 1 Funds. The threshold went up from 51% to 62% to access Title 1 Funds, so school stakeholders are suggested to complete the Free and Reduced Lunch application.
 - E. Nurse Report - Pioneer Middle School does have a nurse on campus.
 - F. All schools should have access to the Telehealth Virtual Doctor.
 - G. Discussion from the district regarding the installation of vape detectors throughout each school, which would send alerts to staff without setting off fire alarms.
