1. Welcome & Call to Order

2. Unfinished Business

- a. Scholastic Book Fair Question- Media Center Specialist and Scholastic Book Fair follow the FL Statute. All books brought in by Scholastic are audited again upon arrival by Ms. Williams and Ms. July before placing them on shelves for purchase
- b. February Minutes Edit to include Adjournment Time of 8:45am. No feedback. Jacqueline Pabon motioned to approve. Motion seconded by Marlene Sanchez. None opposed. Motion approved.

3. School Improvement Plan (SIP) Monitoring

- Schools Comparable data from PM2 to PM2 for both ELA and Math provided to stakeholders. PM2 data change is dependent on grade level. Kindergarten and 4th grade ELA percent in the green. Grades 1 and Grades 5 reflect a red negative percent change. Overall, our Math data shows less percent change from last year to this year. As we look at our new business of a 21st CCLC, we need to look at the breakdown for our ELL, FRL, and SWD. Our SWD is our target. We have implemented school wide, crunch time plans to continue to close achievement gaps for students by providing them in time instruction.
- Enrollment data shows a decrease in enrollment at Tamarac. Significant decrease in the students that entered Kindergarten this year.
- Attendance has improved from last year. We encourage students to come to school daily and arrive on time to ensure they are maximizing instruction time.

4. Accountability Funds

a. Last month's approved quotes have been submitted. The Promethean Board request is in process. The Omega Man Assembly quote has been submitted, but the vendor will need to be approved prior to processing. Date is still set for our Family Engagement Night which includes our Math Academic Night and OmegaMan Show. Students will have an assembly in the morning. Finalization of OmegaMan Assembly date is based on vendor approval status. b. New Balance of \$1,067.96 after processing of above quotes. c. No new quotes received at this time. Any additional quotes for this school year will need to be submitted to prior to April's SAC Meeting to be approved in May.

5. New Business

- o *21st Century Community Learning Center (CCLC)*

Tamarac is writing a grant for 21st CCLC. As we reviewed our school wide data, we can see that this program would be of importance to bring to Tamarac to engage students in enrichment outside of the school day. It is federally funded initiative that provides high quality after school and summer programs. As of now we are looking at 70 spots which will be offered to SWD first, then those with the highest needs. ASP is still to remain on campus. Overview of Survey to both Staff and Parents. The 30 responses showed an initial positive response and needed to have the 21st CCLC at Tamarac. Activities and programs that had the most feedback were ELA and Math support, Homework Help, and Social Emotional Learning. Parent Survey updated to remove requirement of email address. Will be resent out.
