





- I. **Voting of SAF Secretary**
- II. **Vape Detector Update – Chief Michael Gregory, BCPS**
 - A. Non-recording vape detectors will be installed in middle and high school restrooms to identify aerosols (THC/nicotine) and air quality changes. Real-time alerts will be sent to staff for response.
 - B. RFP (Request for Proposal) expected by December. Training for staff and information for families will be provided prior to rollout.
- III. **BCPS Showcase**

- IV. **BCPS Website Migration & Cares Initiative**
 - A. Website Migration: 80,000 pages moved to a new, modern platform focused on accessibility and enrollment; updates continue as issues are resolved.
 - B. BCPS Cares: Streamlines parent concern reporting, routing issues to appropriate staff for faster and more transparent communication.
- V. **SAC Funding and Rollover Dollars**
 - A. District eliminated SAC rollover funds for 2024–25 without prior notice, affecting tutoring, prep, and incentive programs.
 - B. Motion passed requesting the District return Accountability and SIP rollover funds and allow 120 school days or until the end of 2025–26 to spend them.
 - C. As of 10/17, schools were notified that their SAC funding is being returned; the District has been asked to provide clear directions and deadlines regarding use of funds.

 - A. No boundary or consolidation changes proposed for Coral Springs middle schools.
