A meeting of the Coral Park Elementary School Advisory Council was held in room 901 on March 19, 2025

Cochair, Hoanca Schneider called the meeting to order at 7:30. Laura Worthington recorded the minutes for this meeting.

Minutes:

February minutes were reviewed. A vote was taken by a show of hands of SAC members in attendance and the minutes were approved.

New Business:

- Review of current SIP and input was sought on development of 2025-2026
 School Improvement Plan
 - Ourrent school year's Title I Addendum was reviewed, and questions were asked regarding funding for Title I next year. Ms. Johnson asked how much money Coal Park received from Title I funds this year and how the money was spent. Ms. Pontillo answered that the amount was approximately \$200,000 and was used for additional staff to support reading and math.
