SAC Meeting Minutes

Wednesday, May 28th, 2025, at 7:15 am

Call to Order:

A meeting of the Coral Park Elementary School Advisory Council was held in room 901 on May 28th, 2025

Cochair, Hoanca Schneider called the meeting to order at 7:30. Laura Worthington recorded the minutes for this meeting.

Minutes:

March minutes were reviewed. A vote was taken by a show of hands of SAC members in attendance and the minutes were approved.

New Business:

- Ms. Pontillo informed the SAC committee that Coral Park would not be a Title I school for the upcoming 2025-2026 school year. Mrs. Johnson asked for further clarification on how the district had reconfigured the calculations regarding which schools would and would not qualify as Title I moving forward. Ms. Pontillo explained that a school being designated as Title I was based on the percentage of students who qualified for free or reduced lunch and that the district had adjusted the scale. Previously, a school needed at least 50% FRL to qualify, but the percentage had now increased to 63%. Coral Park had met the 50% but falls short of the new 63% requirement.
- Reviewed the process for the draft School Improvement Plan which is due earlier this year at the end of July.
- Presentation of the 2025-2026 school budget including changes in funds and positions. Explanation was given how the loss in funding has had a domino effect on staff positions and how Coral Park had to surplus one teacher and two paraprofessionals. Ms. Pontillo also mentioned how what is currently being presented can change over the summer.
- Reviewed the possibility of accountability funds not rolling over as they always have in previous years.
