SAC Minutes - November 18, 2025

Call to Order:

A meeting of the Lyons Creek Middle School Advisory Council was held in the DLR on November 18th, 2025. Shena Wright called the meeting to order at 8:38 a.m. Courtney Johnson will record minutes for this meeting.

New Business:

1. BTU clarification shared by Robert Kozell (Informational)

- SAC does not handle teacher schedules
- Advises on student achievement
- This falls under collective bargaining
- Only bargaining unit staff vote on this
- Based on the staff vote of more than 66 2/3% with over 80% of the staff voting they chose to keep the current schedule

2. Review of District Mandate: Transition

- Ms. Itty was requested to call an emergency staff meeting
- Shared information as to why to change to this model
 - i. Loss of students
 - ii. Cost of everything has increased
 - iii. Financial sustainability is no longer financially viable due to costs
 - iv. Projected savings: more than \$30 million annually
 - v. Article 15 of BTU agreement: district may change high school schedule options
 - vi. Nothing would change this year
 - vii. Changes for instructional staff:
 - 1. 6 classes-1 planning
 - 2. Consistent staff model
 - 3. Support for collaboration
 - 4. Extra periods-only able to teach 1 extra period

3. Presentation of Three Schedule Options and Discussion:

- Straight 7-like now just add a class period
 - i. Shared +/-
- Rotator 7: 6 periods with the 7th moves
 - i. Shared +/-
- Modified A/B
 - i. Shared +/-
- Straight 7 is the only one that gives teachers a planning every day
- Shared timeline
- Schools without the decision by December 12th will be placed on a straight 7

- Parent asked if teachers voted to change
 - i. By issuing this mandate it violates our contract
 - ii. We had a preliminary vote as to whether they were interested in keeping our schedule

- ii. Would go to the teachers to accept or reject
- Itty-based on what district has told us-if no choice by 12/12-we will be on a straight 7
- Ms. Benner: Can we revoke?
 - i. We can have 1 more meeting if necessary
 - 1. If we do not choose, we will have straight 7





