The start of the school year consists of finalizing the School Improvement Plan. Ms. Henry said our school's goals have been put in this year's SIP plan using last year's test scores and other data collected from department heads and administrators. Our focus is on learning gains for all students. Last year's learning gains were 66%, we want to increase that percentage – comparing last years to this coming year's data. The SIP plan also includes the school-wide positive behavior plan. School-wide behavior expectation assemblies have taken place in August to teach students our school-wide expectations.

Ms. Silva added information about our positive behavior plan using Cougar Bucks to reinforce positive behavior.
