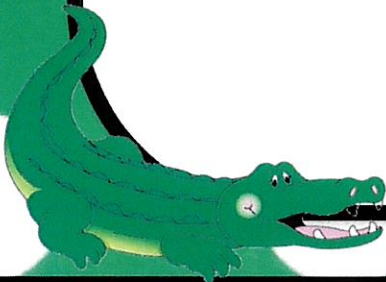

General Meeting – Tuesday, March 31, 2026 – 2:30 PM
