AP Rolle – SAC Number Projection Presentation

Shared the estimated 2025-2026 budget based FTE. Estimated FTE count is 515 students. The categories were identified and the projected total \$4,212,505. Comparison of core teachers/sections were discussed. ESE projected budget is \$179,591. School Accountability Funds have been utilized more this year than other years. He encouraged more parent participation to help make decisions for spending. Accountability funds haven't been determined for 2025-2026 school year. Decisions are made based on positions, not people.
