





- **Welcome all members** *Ms. Lazzare*
  - Ms. Lazzare welcomes everyone present in the meeting.
- **Approval of minutes** *Ms. Lazzare*
  - Ms. Lazzare gives a brief overview of what was discussed in the previous meeting in September.
  - September minutes were approved by Dr. Pascal (parent) and Mr. Alejo seconds (principal).
- **Principal's Report** *Mr. Alejo*
  - Mr. Alejo (principal) reports there has been conversation at the last School Board Meeting about possibly redefining our school due to help increase our enrollment.
  - The structure of the building will be reviewed
  - Mr. Alejo states once he receives more information, he will share with the committee
  - Current school enrollment, approximately 530 students
  - Funding was approved to get an additional ESE teacher for Primary grades to allow smaller class sizes
  - Mr. Alejo states he is in the process of hiring another staff member
