- Ms. Lazarre (staff & parent) welcomes everyone present at the meeting.

Approval of minutes

Ms. Lazarre

- Ms. Lazarre (staff & parent) gives a brief overview of what was discussed in the previous meeting in November.
- November minutes were approved by Ms. Badal (parent) and Dr. Paschal (parent) seconds.

Florida Recognition Funds

Ms. Lazarre

- School Recognition Funds – Mr. Alejo explains the school will receive approximately \$42,836, minus fringe benefits for achieving an A grade in the 2024-25 school year .
- Florida Recognition Funds Proposal:
 - _____ 100% of the awarded funds will be used as a one-time bonus distributed equally amongst staff employed by Coconut Palm Elementary School that worked at least 80% of the 2024-2025 school year. The School's Psychologist, School Social Worker, and School Food Nutrition Service Manager would receive a one-time bonus of \$225.00
 - _____ 80% of the awarded funds will be used as a one-time bonus distributed equally amongst staff employed by Coconut Palm Elementary School that worked at least 80% of the 2024-2025 school year. The School's Psychologist, School Social Worker, and School Food Nutrition Service Manager would receive a one-time bonus of \$225.00
 - _____ 20% of the funds will be used for student initiatives, including supplemental materials. Incentives, and/or site licenses.
 - _____ None of the above
- Ms. Walters (staff & parent) ask if we can add another option – Staff working less than 80% due to medical emergencies will still receive the A+ funds.
- Dr. Paschal (parent) suggests we adjust the proposal year to year, and revise for particular situations.
- Ms. Lazarre (staff & parent) asks Ms. Walters (staff & parent) to send her proposal to the SAC committee to be added in the future.
- The SAC committee motions to move forward with approving the Florida Recognition Funds Proposal for Coconut Palm with the correction of a typo to be placed on the proposal.
- Revision- The 2nd option: 80% of the awarded funds will be used as a one-time bonus distributed equally amongst staff employed by Coconut Palm Elementary School that worked at least 80% of the 2024-2025 school year. The School's Psychologist, School Social Worker, and School Food Nutrition Service Manager would receive a one-time bonus of \$225.00 and the 3rd option: 20% of the funds

will be used for student initiatives, including supplemental materials. Incentives, and/or site licenses will be merged together to make one solid option for the staff.

- The proposal is agreed on by the SAC committee vote. Dr. Paschal (parent) approves, and Mr. Palelis (staff) seconds. The entire SAC committee present are ALL in favor.
