4. **SAC Updates- Tiffany Haynes**
A+ Funds: Total: \$ 63,971-Ms. Garber has processed the paperwork to release A+ Funds. Funds should be released in February. Final Amount: 3 Staff Members received \$150 (School Psychologist, Social Worker, and ESE Family Counselor). Remaining Staff: \$698.03 Remaining Funds: \$0.07. 5. **Principal Report-Ms. Zdanowicz**
Ms. Zdanowicz attend the Area Advisory meeting. She presented information on student testing. She shared how Challenger uses the testing data. A lot of the discussion for the meeting was centered around student assessments. The parents at the meeting feel that students are taking too many assessments. Students have completed PM2 testing and currently finishing up iReady diagnostic testing. Data is showing an upward trend. Staff will be having data conversations with the students. Looking to do a PreK-12 model with Millennium- More information to come.
6. **Safety/School Wide Behavior Update/SESIR Report: Intern Principal Claudine Dunbar-Creary**
No SESIR incidents, Referrals are down when compared to this time last year. We will be providing incentives to motivate the upper grades.
7. **Title I Updates/P.F.E.P- Kelly Barbera (Title I Liaison)**
We will be making some decisions at the next meeting for next year's Title I plan.
8. **Data and Testing Updates-Tia Holness (Student Support)**
Challenger was picked to participate in the The National Assessment of Educational Progress (NAEP), known as "The Nation's Report Card," test for 4th grade students. It is a random selection of 4th graders and they will test on February 5th .
