- II. Morning ELO will recommence next week in the media center starting at 7:50AM.

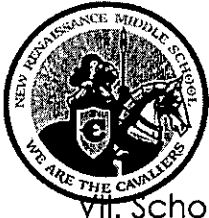
IV. Financial Report: **Accountability Starting Balance: \$13,291.37**
