The school is on track with its improvement goals, showing growth in ELA proficiency from 43% to 47% and focusing on supporting underperforming students with disabilities through differentiated instruction.

II. Acceleration efforts have improved, with a decrease to 68%, and progress on math goals and FAST
PM2 assessments indicates overall positive momentum, with a call for continued parent support in extended learning opportunities.

VIII. Library Updates - Mrs. Sangster

- I. The media center holds about 10,800 books with an average collection age of 2003, exceeding the 15year guideline, though the school meets the requirement of 10 books per student.
- II. A three-year plan is in place to update the collection, starting with weeding out older fiction and biographies while continuously ordering new books to address content gaps and ensure compliance.

IX. Kids of Character- Ms. Burke

- I. Student of the Month Recognition: Students were selected as "Kids of Character" based on nominations from multiple teachers, highlighting their exemplary behavior and contributions.
- II. Parent Appreciation: Acknowledged the role of parents in fostering these character traits, emphasizing how their support positively impacts student success.




